Summary Annual Report for

STEAMSHIP TRADE ASSOCIATION OF BALTIMORE, INCORPORATED – INTERNATIONAL LONGSHOREMEN'S ASSOCIATION (AFL-CIO) SEVERANCE AND ANNUITY PLAN

This is a summary of the annual report for Steamship Trade Association of Baltimore, Incorporated – International Longshoremen's Association (AFL-CIO) Severance and Annuity Plan, EIN 52-2035147, Plan Number 001, for the period October 1, 2020 to September 30, 2021. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

A total of 2,541 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$103,953,827 as of September 30, 2021 compared to \$88,868,289 as of October 1, 2020. During the plan year the plan experienced an increase in its net assets of \$15,085,538. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$35,034,092. This income included employer contributions of \$15,894,438, employee contributions of \$0, realized gains of \$2,352,438 from the sale of assets, earnings from investments of \$15,348,102, plan expense reimbursement from Mass Mutual of \$450,000, rollovers of \$938,650, and other income of \$50,464.

Plan expenses were \$19,948,554. These expenses included \$872,781 in administrative expenses and \$19,075,773 in benefits paid to participants and beneficiaries.
